Eye contact

Skin contact

Ingestion

Stop if the exposed person feels sick as vomiting may be dangerous. Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs. the head should be kept low so that vomit does not enter the lungs. Get medical attention. If necessary, call a poison center or physician. Small spill

8.2 Exposure controls

Appropriate engineering controls
